29. MINUTES OF EXECUTIVE MEETING HELD ON 1st June 2021

30. MATTERS ARISING

31. CORRESPONDENCE

Loddon White Dolphins - asking for help to find a new teacher.

Swim England East Region – requesting information on 2022 affiliation fees.

Swim England East Region – Confirming that the ER Masters Championships will go ahead. NB Masters correspondence is being sent to the Secretary until a new County Masters Secretary is found.

Swim England East Region – Minutes from the inaugural meeting of the Forum for County Chairs and Secretaries. (Future Meetings 22nd September 2021. 13 December 2021, 16th March 2022).

Swim England Leadership Group – feedback concerning the 2021 National Team Championships cancellation. **Pat Hollis (Past President)** – Following her death, Kay Starling's Past President's badge has been passed back to the County in the hope that a future Past President may feel honoured to have it. This has happened in the past e.g. Sid Day's badge was awarded to Richard Belson.

32. TREASURER'S REPORT

The balance sheet had been circulated in advance of the meeting.

There has been little movement since the last balance sheet was produced. Income is mainly from affiliations and Open Water fees. Expenditure includes course support and grants back to clubs. Zoom fees and insurance premiums have also been paid.

The Budget for the coming year had also been circulated. This is the best estimate after all financial considerations have been taken into account.

- Galas this allows for the County Championships, Challenge and Warwick Thompson but does not include the Norfolk Masters Meet and the Junior/Senior Inter-Club Gala as these have no intended dates.
- Affiliation Fees- One penny per member.
- A budget for Open Water training has been included.

33. AFFILIATION FEES

The Treasurer proposed that the affiliation fee remains at 1p per member. Course Support has been removed from the Budget as this equates to roughly the same amount collected in fees before they were reduced. Instead of charging fees at a higher rate and clubs claiming for training courses, the money would be retained by clubs to spend on courses or to do with as they wish.

Applications for course support will still be honoured up until 31st October 2021. Applications after this date will be considered until the spent and committed money in the current budget (£3000) is used. The Development Group will look at the application process but it will initially be on the same basis as the current scheme.

Development camps and sending County teams to competitions would be unaffected they can be funded by surpluses on galas.

The affiliation fee of 1p was approved.

34. VACANCIES AND SUCCESSION PLANNING

Filling vacancies (Masters Secretary, County Coach, Team Manager/Competitions Secretary) has proved problematic as everyone's energy has been focussed on getting back to training.

- County Coach: Bethany Coombs (Level 3 coach with a degree in Physical education) was put forward as County Coach. Beth swam with CONSC and currently coaches with them. Agreed.
- Masters Secretary: Several people have been approached but so far no one has stepped forward. The
 Norfolk Masters Meet usually held in May is therefore unlikely to go ahead. The gala is best organised
 by a sub-committee to share the work load with the Masters Secretary at the helm.
- Team Manager/Competitions Secretary: Still vacant.
